in exercising the authority granted by Resolution 09 of January 12, 1993, and

CONSIDERING:

That CLAUDIA DE MARILLAC GUZMAN AGUDELO, identified by citizen's I.D. No. 31.469.935 issued in Yumbo (Valle), requested this Ministry to be issued a license to exercise Official Translator and Interpreter functions in accordance with Decrees 382 and 2257 of 1951.

That the requesting party has attached the required documents to her request to prove compliance with the requirements, as follows:

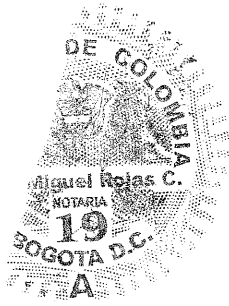
- a. An authenticated copy of the Judicial Certificate registered under T.D. 31.469.935, issued by the Administrative Department of Security (DAS), certifying that the individual has no criminal or police record.
- b. A certificate issued by the Head of the Legal Office of the Ministry of National Education accrediting her eligibility as Official Translator and Interpreter from ENGLISH-SPANISH, SPANISH-ENGLISH.
- c. Three good conduct statements provided before Notary Public 8, 11 and 13 of the Circle of Cali.
- d. A Birth Certificate issued by Notary Public 1 of the Circle of Cali stating the individual's legal age.

HEREBY RESOLVES:

ARTICLE ONE: Issuing a license to CLAUDIA DE MARILLAC GUZMAN AGUDELO, identified with citizen's I.D. No. 31.469.935 of Yumbo (Valle), to exercise functions as an Official Translator and Interpreter from ENGLISH SPANISH, SPANISH-ENGLISH, after having registered her name before the Superior Court of the Judicial District corresponding to the territory where she will exercise their functions.

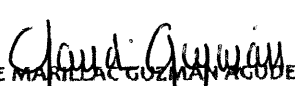
